I request you to takeover the S.T. Residential Educational Institutions alongwith the staff working at present in these institutions pending finalisation of options. The number of vacancies will be decided after having discussions with the A.P.R.E.I. Teaching and Non-teaching Associations. After finalisation of options, the staff will be transferred to your Society on permanent basis and till such time the services of the staff working in S.T. Residential Educational Institutions may be treated as on deputation.

I further request you kindly arrange to issue supporting Government orders to handover the ST/PTG Residential Educational Institutions to the A.P.T.W.A. & R.E. Society with effect from 1.6.1999.
